SOC returned partial checks to students for classes they did not attend and paid the teachers for their time. We will start clean when we can reopen.


Other new business: none.

# BOARD MEETING



In response to the latest coronavirus news, AKC Government Relations (AKC GR) has learned that Legislative Leaders in New England have taken various steps to mitigate the outbreak. Please refer to the summary for each state below and know that we will keep you informed of changes as they develop.

Connecticut: After initially re-scheduling public hearings from last week on bills impacting dogs, the General Assembly has now closed the capitol to suspend legislative activities through March 30th. The understanding is that bills heard prior to the shutdown remain active to be voted upon, but those not heard are inactive. Only one bill included in AKC GR's [prior alert](#), [HB 5368](#) had a hearing and has been voted favorably by committee.

[HB 5368](#) would establish a taskforce composed of political appointees to study the use of breed of dog as an underwriting factor for homeowner's insurance policies. AKC believes that insurance companies should determine coverage of a dog-owning household based on the dog's deeds, not the dog's breed. If a dog is a well-behaved member of the household and the community, there is no reason to deny or cancel coverage. As written, this bill provides no assurances that the taskforce's composition would be fairly balanced in representing the perspectives of dog owners, in addition to insurers.

WHAT YOU CAN DO: All dog owners in Connecticut are encouraged to email their state representative and senator requesting they oppose HB 5368. To identify your legislators and how to contact them, go to <https://www.cga.ct.gov/asp/menu/cgafindleg.asp>. Let them know you are opposed to HB 5368 allowing insurance industry members to make homeowners policy recommendations without the input of responsible dog owners.

Maine: The Maine Legislature announced on Friday that the 2020 session would end on Tuesday, March 17. Members of the budget committee were expected to work over the weekend to finalize a spending proposal, including provisions for a response to the coronavirus, by the Tuesday deadline. Other measures endorsed by legislative panels could be considered by the Legislature when it meets on what is likely to be a marathon day on Tuesday. Unfinished matters are said to be carried over until the Legislature reconvenes.

Massachusetts: The General Court in Massachusetts has postponed until further notice committee hearings and public events scheduled in the statehouse. The 2020 legislative calendar does not officially require adjournment until July 31, 2020.

New Hampshire: In New Hampshire, the General Court has suspended all legislative activities for at least one week, March 16-20, 2020. The State House will be closed to legislative members, legislative staff, and visitors, but remain open for governmental operations until further notice.

Rhode Island: There will be no General Assembly sessions during the week of March 16-20, 2020. All legislative offices will also be closed.

Vermont: The Vermont Legislature has adjourned until Tuesday, March 24, 2020. The State House will be closed during the adjournment. All staff except essential security and IT personnel will work remotely.

# Stewards Corner

## Stewarding at Scent Work Trials

**Define Steward:** An individual who assists in the orderly conduction of the trial . Some stewards will work in the search area and act as assistants to the judge, and others will work in the staging area and be responsible for ushering teams to the start line when it is their turn to search . Stewards and Hide Steward . The club shall arrange for one or more stewards to organize and call in the exhibitors and assist the judges.

Judging Schedule: Dogs within a class shall be run in the judging program order except *that the steward* has the discretion to allow a dog to be judged out of sequence at the request of the handler *if, in the opinion of the steward*, a valid conflict exists

**Section 29.** The Stewards. The stewards are in charge of bringing each team to the start line (gate steward(s), carrying out orders from the judge (such as repositioning items in the search area) and any other duties as required by the club or the judge . The club may appoint as many stewards as they need to complete the required tasks.



**Section 30.** Setting of Hides. For each class in the Odor Search division, *the judge* is responsible for ensuring that the scent is placed in the appropriate hide location(s) that they have chosen. The judge may set the hides themselves or may direct a qualified individual (as determined by the judge) to do so with their supervision . The individual setting hides should wear latex, nitrile, or vinyl gloves when doing so, and must not touch any other items until the gloves are removed . For classes in the Handler Discrimination division, the judge must designate another individual to set the hides for them (the Hide Steward)

**Section 31.** Official Timer. Each class must have an official timer who will monitor the official time for the class and communicate to the judge the final run time to the hundredth of a second . The official timer will give a 30-second warning to every competitor in the Novice, Advanced, and Excellent level classes (no 30-second warning will be given in Master level classes or the Detective Class) . However, if the warning is late or is not given due to circumstance or oversight, no re-run is due . The search time shall be determined as follows:

- For novice classes: The official time shall start when the dog's nose crosses the start line, or when any part of the handler's body crosses the start line, whichever is first . The official time shall stop when the handler calls "Alert ."
- For classes with multiple hides in a single search area: The official time shall start when the dog's nose crosses the start line, or when any part of the handler's body crosses the start line, whichever is first . The official time shall stop when the handler calls "Finish ."
- For classes with multiple search areas: The official time for the first search area shall start when the dog's nose crosses the start line for that search area, or when any part of the handler's body crosses the start line, whichever is first . The official time shall stop when the handler calls "Finish ." The official time for the first search area will then be recorded on the score sheet while the team is led to the next search area . The timer will then be reset, and the timing will follow the same procedure for each additional search area . The official time for each search area will be recorded independently and then combined for a total time.

SOC has two gate stewards. One at the top of the ramp, and the second at the bottom. The first makes sure that the next team is ready to enter the ring timely, to efficiently move along the trial. The second is to make sure the team on deck is ready, and to fine the next team, in the event that one is needed. Additionally, SOC has a Score Runner, someone you will periodically collect score sheets from the judge to allow the secretary to timely record and post results.

# Proposed Bylaw Changes

Persuant to Article VII of our Constitution and Bylaws, attached are the proposed amended bylaws. The **red writing** below is the new proposed language. Bolded, in parentheses, and with strike through is the old language.

## ARTICLE II

### Meetings and Voting

#### SECTION 1: CLUB MEETINGS

~~(A regular meeting of the Club shall be held each month)~~ The club membership shall meet a minimum of six (6) times per year in the greater Westbrook, Maine area, at such hour and place as may be designated by the Board of Directors. Written notice of each such meeting shall be given by the Secretary, at least 10 days prior to the date of the meeting, by mail, or email as outlined in Article XI of these Bylaws. The quorum for such meetings shall be 20% of the members in good standing.
