Is that what we really want to do to our most steadfast companions? The more we learn about canine structure, the more we understand what is reasonable to ask of our dogs, given their physical strengths and weaknesses.

Pat Hastings is well respected in the dog-world as an educator, author and AKC judge. Well-known for her Puppy Puzzle DVD, she evaluates the structural quality of over 350 litters per year.

Hands-on work with attendees+dogs concludes the day.
