Qualifying scores are required for all prizes except in Non-Regular Class. NOTE: To be eligible for either the Jr. Handler or Sr. Handler trophy you must register at the trophy table prior to the start of your Class.

Anyone winning an award **MUST** be present at the end of each Trial in order to receive the award. Awards cannot be picked up by anyone other than the person winning the award. Awards not claimed at the end of each trial will become the property of Saccarappa Obedience Club, Inc.

NOTICE TO EXHIBITORS

An event service fee of \$1.50 and \$.50 recording fee for the Obedience Classes and for the Rally Classes a \$3.00 recording fee will be required for each dog entered applicable only to the first entry in each Trial. This fee is collected by Saccarappa Obedience Club, Inc. and paid to the American Kennel Club. (American Kennel Club Rule, Chapter 11, Section 2)

Jump heights for obedience and rally classes needed. "DOG" means either sex. Exhibitors should follow their veterinarians' recommendations to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

ERRORS: Owners are responsible for errors on entry forms. No refund will be made in event of such errors.

ENTRY FEES: Will not be refunded if dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by the Obedience Trial/Rally Committee. If because of riots, civil disturbances, or other acts beyond the control of the management it is impossible to open or to complete the show, no refund fees will be made.

ENTRIES: Telegraph, telephone, fax, e-mail and unsigned entries cannot be accepted. Entries not on official AKC entry forms or photocopies of entry forms without the agreement and rules on the reverse side of the official AKC entry form are not acceptable. Please send express entries with no signature required.

HANDLERS: Handlers are responsible to be ready with his/her dog at ringside when required. Dogs not needed for further judging may be excused. There shall be no drilling nor intensive or corrective training of dogs on the show grounds or premises.
